extraction

 Arbour Farms owns an additional 38.2 ha of land that will remain as buffer lands





Major Changes as a Result of Agency Review of Updated Reports

- Updated Adaptive Management Plan to protect the natural environment and water resources
- Reduced extraction area to increase setback from adjacent butternut tree
- Removed certain berms from environmental setback areas
- Completed noise assessment for vacant lot analysis
- Significant updates to entrance / exit design and relocated the driveway location



Haul Route

- Airport road is the identified main route. The Township Official Plan directs truck traffic to utilize this road and it is the only arterial road in the Township
- A traffic and a safety analysis was completed and peer reviewed by the Township

 The peer reviewer agrees Airport Road has capacity and can accommodate truck traffic to and from the site, subject to an appropriate entrance/exit design





Significant Changes to Entrance / Exit to Address County's Concerns

- The extent of the revisions to the entrance / exit exceeded the requirements of the Peer Reviewer
- County of Dufferin is satisfied and is prepared to issue the entrance/exit permit
- The revised driveway location meets the County's sight line requirements
- The County of Dufferin has said that they will be adding "No Truck Stopping" signs to this section of Airport Road
- The site has sufficient area to accommodate on-site marshalling
- Ongoing maintenance to Airport Road is addressed through taxes and levies

Updated Adaptive Management Plan Protects the Natural Environment / Water Resources / Fisheries

- An updated Adaptive Management Plan dated October, 2013
 has been filed with the Agencies. The Ministry of Natural
 Resources and the Ministry of the Environment have signed off
 on the Plan.
- The updated Adaptive Management Plan will be included on the Site Plans and any operator will be required to comply with the conditions of the Adaptive Management Plan

<u>Site Preparation - Rehabilitation - Production</u>

- Monday to Saturday: 7:00 am to 7:00 pm, excluding vegetation clearing May 1st through July 31st
- Washing operations or combined below water extraction and washing operations will not occur between September 15 and April 15

Shipping

March to October

- Monday to Thursday: 7:00 am to 6:00 pm
- Friday: 7:00 am to noon
- No Shipping from Friday at noon until Monday at 7:00 am

November to February

- Monday to Thursday 8:00 am to 5:00 pm
- Friday: 8:00 am to noon
- No Shipping from Friday at noon until Monday at 8:00 am
- 24/7 for winter sand operation

Hours of operation will be included on the updated site plans and any operator will be required to comply with these hours.

- The noise impact of the haul route and winter / night time sand operation were included in the noise impact assessment
- As requested by the MOE, a vacant lot analysis was completed
- The Ministry of the Environment has reviewed the noise impact assessment and additional analysis by Valcoustics Canada Ltd. and concurs that the MOE Guidelines are satisfied
