PROPOSAL: for the construction of a new Stormwater Management Pond, as

indicated on the attached or noted drawing(s), on the above property during the period of September 26, 2003 and September 26, 2004,

subject to the following conditions:

- That all development and site alteration is subject to federal, provincial and municipal statutes, regulations and by-laws, such as the Municipal Act, Zoning and Top Soil By-Laws, the Federal Fisheries Act, Navigable Waters Act, Public Lands Act, Lakes and Rivers Improvement Act, Drainage Act, Environmental Protection Act and the Ontario Water Resources Act.
- That the proposed works as described in your application may require a "Permit to Take Water" under the <u>Ontario Water Resources Act</u> from the Ministry of Environment (MOE). Please contact the MOE District office at (519) 826-4255 for Dufferin County prior to commencement of the project.
- 3) That this approval does not confer upon you any right to occupy, develop or flood lands owned by other persons or agencies.
- That appropriate erosion control methods are installed <u>prior to construction</u> and maintained until all disturbed areas are stabilized, to ensure that sediments do not enter any watercourse, wetland, lake, pond or sensitive area within the property or adjacent properties. When an erosion and sediment control plan appears to be inadequate, the deficiencies must be addressed and additional measures or practices implemented as needed. It is the responsibility of the owner and the owner's representative (if contracted) to implement, monitor and maintain all erosion/sedimentation control structures and practices until vegetative cover has been successfully established.

- 5) That nothing herein authorizes any person to carry out work or undertaking, which may result in harmful alteration, disruption or destruction of fish habitat or any fishery.
- 6) That the works be carried out in accordance with the following submissions:
 - Drawing titled "Stormwater Management Pond Mansfield Ski Club" produced by Stantec Consulting Ltd., dated October 2002.
 - Report titled "Snowmelt Management System Design Brief, Mansfield Ski Club, Township of Mulmur", produced by Stantec Consulting Ltd., dated October 22, 2002 (On File).
- 7) That dewatering of the site (if any) must occur slowly and the pumped/drained water should be filtered by appropriate erosion control measures prior to entering any watercourse. Permission must be obtained from adjacent owners prior to discharging overland water to their lands. Pumping shall be monitored and maintained on at least a daily basis.
- 8) That any excess excavated material must be placed at least 30 metres from any lake, wetland, watercourse, floodplain or fill regulated area.
- 9) That any disturbed areas or fill material stock piled for longer than 30 days must be stabilized and re-vegetated to prevent erosion.
- 10) The Authority may carry out periodic inspections during construction.
- 11) That the owner provides copies of this approval letter to any contracting or construction supervisor(s) who must have a copy on-site for inspection by an officer when requested.

Note: It is the responsibility of the applicant to carry out the works in accordance with the above conditions. Failure to do so may result in withdrawal of the permit and possible action in accordance with the <u>Conservation Authorities Act</u>.


