Council Meeting Highlights - February 5, 2020

- The Council heard a presentation from Joanne Jordan of Family Transition Place to highlight the goals of their new Rural Response program which strives to break down unique barriers to accessing services for rural women. - Jamie Lundy appeared before Council to discuss his application to cut trees on his property to allow irreation equipment to function better.
- Council discussed their feedback on the draft Community Energy Plan to be provided back to the consultant.
- At the last Council meeting, there was a Mansfield resident who asked for additional information as it related to the Mansfield Water System. Council discussed this matter and felt it would be a good idea to provide the water users with an information newsletter on the system, budget, etc.
- Council passed a resolution to join the FCM-ICLEI Partners for Climate Protection Program.
- A Zoning By-Law Amendment and a Site Plan Agreement was approved for Ron Little Trucking to legalize the trucking use and to delineate the extent of the development for its continued operation.
- The Tax Rate By-Law for 2020 was approved.
- Staff have been asked to look at the remuneration By-Law and the per diem policy to expedite and improve the current process of Council representation at various events, training and meetings.
- Zoning By-Law Z08-2019 for Mansfield Ski Club was not approved.

program from the Province for the construction and installation of our new Mulmur Community Signs. Thanks to the Economic Development Committee and Township staff for your good work with this exciting project! The County is working on Mulmur's gateway signage which will be coming soon.

We have a Fire By-law that sets out conditions if you want to do an open burn. For example, the fire must be under constant supervision, have an extinguishing agent on hand and be under control from the time of lighting until it is totally extinguished.
