



COUNCIL MINUTES November 2, 2022 – 9:00 AM

1.0 CALL TO ORDER

The Mayor called the meeting to order at 9:02 a.m.

2.0 LAND ACKNOWLEDGEMENT

We begin this meeting by acknowledging that we are meeting upon the traditional Indigenous lands of the Tionontati (Petun) and Treaty 18 territory of the Anishinaabe peoples. We recognize and deeply appreciate their historic connection to this place and we also recognize the contributions Indigenous peoples have made, both in shaping and strengthening our community, province and country as a whole.

The Mayor acknowledged the completion of the 2022 municipal election thanking all involved. Special thanks were given to candidates, those who voted and Councillor Boxem for her service.

An update was provided from the October 28, 2022 Primrose Elementary School parent information session. The Upper Grand District School Board (UGDSB) has committed to providing weekly updates. The design specifications for a new well have been completed. The UGDSB anticipates contracting a well-drilling company in the next two weeks at which point a date to complete test holes will be scheduled. The water tanker and pipe leading into the building will be heat traced to prevent freezing.

Council discussion ensued on the steps being taken to expedite the process. Council directed staff to draft a letter outlining Mulmur's concerns regarding the timeliness of installing the new well.

Tracey Atkinsons provided an update on discussions with the Upper Grand District School Board planning department regarding school capacity and boundary adjustments.

14.1 Bill 23 and More Homes Built Faster

Tracey Atkinson, Planner, presented the proposed legislation of Bill 23 noting its release the day following elections and a commenting period deadline of November 24, 2022.

The proposed legislation includes 9 Schedules amending a number of Acts, including the Conservation Authorities Act, Planning Act, Municipal Act and Development Charges Act.

Discussion ensued on Council's ability to continue to host public meetings. Council expressed concerns with:

- development on floodplains and wetlands;
- downloading of Conservation Authority mandate;
- spending and allocation of development charges;
- development charge exemptions for certain housing types;
- parkland dedication impacts; and
- implications on the education and health care systems.

Silva Yousif, Planner for Dufferin County provided comments on the legislated changes and impacts.

Moved by Cunningham Seconded by Clark

THAT Council receive the report of Tracey Atkinson, Planner, entitled Bill 23;

AND THAT Council direct staff to submit comments by the legislated deadline.

14.2 Environmental Assessment and Development Charges Update

Tracey Atkinson, Planner, presented an update on the Armstrong Subdivision and the need for an Environmental Assessment for the Mansfield Water System. Atkinson confirmed an area specific charge would include all lands and future development within the settlement boundary.

THAT Council receive the report of Tracey Atkinson, Planner, entitled Environmental Assessment and Development Charges Update;

AND THAT Council direct staff to update the Development Charge to introduce an area-specific water charge prior to the July 3, 2024 five year anniversary.

AND THAT Council disband the Committee of Adjustment to meet the legislated deadline to hold public meetings for Consent files B03-2022 Mansfield Church and B04-2022 Lazier on November 30, 2022;

AND THAT Council resume the authority to make decision on consents and minor variances under section 45 of the Planning Act until such time as Council provides direction to advertise and re-establish the Committee of Adjustment.

AND FURTHER THAT the Inaugural Meeting of Council be rescheduled to occur on November 30, 2022.
