6.1 EDC Mandate and Strategic Plan Alignment

Members agree that high speed internet and cell service is still a priority within the Township.

6.2 Events Committee Mandate

Secretary Knechtel provided an update on the Events Committee mandate and the reestablishment as a committee of Council. Members were in favor of one event supporting cycling and equestrian activity in the Township.

6.3 Think Local Market Verbal Update

Member Morris provided a verbal update that the DBOT Think Local Market has been postponed until September 14, 2021. To date, there are 43 venders registered. The Township and Committee are to continue to encourage Mulmur venders to join and participate.

Member Morris will send new information package for distribution at the Township.

Member discussed renting the Township pop-up tents to small business for use at markets and business functions as a way to support, encourage and allow for business participation.

The Township did not receive any submissions to the Open Call for Design/Build Cycling Stations. Members will follow-up with companies that previously expressed interest.

Members reviewed the approved Council locations and discussed what cycling station infrastructure should be included at each location.

AND THAT the Committee seek approval from the NDCC Board of Management for the installation of cycling station infrastructure at the Honeywood Park at the identified location:

AND FURTHER THAT the Committee invite local business to purchase and install cycling infrastructure to partner with the Municipality for inclusion in digital collateral and signage.

Members will consult with cycling groups and bring infrastructure recommendations back at next meeting for purchase.

Members agreed that a sign will be installed at each cycling station and a map of cycling station materials would be included on the website. Member McFarlane will consult with Christian Beausoleil to assist in the development of signage and digital materials to identify and promote Mulmur's cycling infrastructure.

2. MANDATE

The Mandate of the Township EDC is to:

1. Retain, enhance and attract businesses by:

- Helping existing small businesses grow through awareness, red tape reduction, education (Prosperous, G1, A1)
- Actively engage with county, provincial and federal agencies to obtain resources to support local initiatives (Prosperous, G1, A2)

2. Pursue responsible growth in residential and employment areas

 Promote local employment opportunities and awareness (Prosperous, G2, A1)

3. Facilitate education and training for Mulmur residents, entrepreneurs and businesses

 With input from organizations such as Dufferin Board of Trade, identify and support employment programs and opportunities for Mulmur residents and youth (Supportive, G2, A1)

4. Celebrate success of residents including students, volunteers, Mulmur team members and business achievements

• Identify business achievements, including new businesses for recognition at Council and inclusion on the business directory. (Supportive, G4, A1)

3. ACCOUNTABILITY

Report to Council annually on progress and achievements. Council may request update reports at any time on specific projects or initiatives.

4. REMUNERATION

No compensation shall be provided to members of the EDC for their participation.

5. MEETING DETAILS, AGENDA, MINUTES & PROCEDURE

- a) The EDC will meet a minimum of four (4) and a maximum of ten (10) times a year.
- b) The Recording Secretary shall send out meeting invites to all EDC members and post notice of the meeting to the Township website.
- c) Agenda items shall be set by the Committee Chair, in consultation with and under approval of the Recording Secretary.
- d) Members who wish to include an item on the Agenda shall contact the Recording Secretary for consideration.
- e) All meetings shall be conducted in accordance with the Township of Mulmur Procedural By-law.

I am pleased to announce the next application intake for the Rural Economic Development (RED) program will be from August 30, 2021 to October 1, 2021. You can find all program information, including how to apply, on my ministry's website at on August 30, 2021.

In July 2019, we announced the revitalized RED program. Our updates put the focus on outcome-based projects that will have tangible benefits for Ontario's rural and Indigenous communities. The updates to the RED program better align with our government's priorities to remove barriers to investment, open doors to rural economic development and create good jobs across the province.

The program has two project categories:
